While closely working with COP in the planning and implementation of all project components, the DCOP will directly oversee the design and implementation of access to finance component/activities of the program to promote and enhance the supply of inclusive financial services to Cashew Value Chain actors. The DCOP will form strategic partnerships with micro- finance institutions, banks, private sector actors, and other lenders to facilitate the linkage for investments into small and medium-sized cashew producers, processors, traders, smallholder farmers, and the rural community to successfully implement activities and achieve desired results.
		The DCOP is expected to ensure that all Project reports are accurate, well- written, and meet expectations. The DCOP, as requested by the COP, will also represent the Project before a range of audiences and in a variety of platforms, at the national, country and international levels.
