AS A RESULT OF A CIVIL WAR OF SEVERAL DECADES WHICH HAS OCCASIONALLY OVERTAKEN CAPITAL AND MARKET DEVELOPMENT IN THIS REGION, SFL'S WORK IN CASAMANCE FOCUSES ON IMPROVING MARKET CONNECTIONS, PARTICULARLY IN THE CASHEW SECTOR, AND RESETTLEMENT OF FAMILIES DISPLACED BY CONFLICT.
