SENEGAL PROGRAM:

SHELTER FOR LIFE INTERNATIONAL (SFL) HAS BEEN WORKING IN THE CASAMANCE REGION OF SENEGAL SINCE 2012. BECAUSE OF A CIVIL WAR, THE CAPITAL AND MARKET DEVELOPMENT IN THIS REGION HAD BEEN STAGNANT. SFL'S WORK HAS ENABLED THE RECONNECTION BETWEEN FARMS AND MARKETS AND REVITALIZATION OF AGRICULTURAL MARKETS THROUGH REBUILDING OF FARM TO MARKET ROADS. IN 2017, SFL COMPLETED THE CONSTRUCTION OF 133KM OR ROADS, WHICH HAD RESULTED IN HIRING OF OVER 1,000 PEOPLE AND CONNECTING MANY FARM COMMUNITIES TO NATIONAL AND REGIONAL MARKETS. IN 2017 ALONE, SFL COMPLETED THE CONSTRUCTION OF 35KM OF FARM TO MARKET ROADS. ADDITIONALLY, SFL LAUNCHED TWO NEW PROGRAMS; ONE TO ASSIST RETURNING REFUGEES REBUILD THEIR HOMES AND LIVELIHOODS AND ONE TO RESTORE

SHELTER FOR LIFE INTERNATIONAL HAS BEEN WORKING IN AFGHANISTAN SINCE 1998 WITH A PRIMARY FOCUS OF RESTORING THE LIVES OF THE VICTIMS OF THE COUNTRY'S WARS AND DISASTERS AND REBUILDING THEIR COMMUNITIES. MOST OF THE COMMUNITIES WHERE SFL OPERATES ARE RETURNED REFUGEES WHO HAVE STARTED FARMING IN THEIR ANCESTRAL LAND.
